MUNICIPAL ORDINANCE NO. 11th-141-2025

AN ORDINANCE APPROVING THE PROPOSED CASH INCENTIVES, CASH PRIZES, PROVISIONS OF IN-KIND ITEMS/FOOD PACKS IN RELATION TO THE PROGRAMS IMPLEMENTED BY THE MSWDO SOURCED FROM THE PERSONS WITH DISABILITY (PWD) FUND.

BE IT ORDAINED by the Sangguniang Bayan of Molave, Zamboanga del Sur, that:

SECTION 1. PURPOSE. The purpose of giving cash incentives, cash prizes, provisions of in-kind items/food packs to person with disability in the programs of the Municipal Social Welfare and Development Office (MSWDO) is multi-faceted and serves both individual and community goals. It promotes positive behavior and raise awareness about the importance of social programs and services, encouraging more PWD Molavenians to engage and benefit from the available support. Furthermore, promoting the MSWD's mission to uplift marginalized or vulnerable communities.

SECTION 2. PROPOSED CASH INCENTIVES, CASH PRIZES, PROVISIONS OF IN-KIND ITEMS/FOOD PACKS IN RELATION TO THE PROGRAMS IMPLEMENTED BY THE MSWDO.

PROGRAMS	AMOUNT
Celebration of National Disability and Rights Weeks on July 2025	Cash prizes in the total amount of Php10,000.00
Year-End PWDs Assembly on December 2025	Cash prizes of the parlor games in the total amount of Php10,000.00
Grant of Cash Incentives to the PWD President of 25 Barangays Year-round	Php500.00 per month with a total amount of Php150,000.00
Provisions of in-kind items/ food packs for the Celebration of the National Disability Rights weeks on July 2025	Rice, Milo, canned goods good for 150 pax
Provisions of in-kind items/ food packs for the conduct of the Year -end General Assembly on December 2025	

SECTION 3. IMPLEMENTATION AND DISTRIBUTION. The MSWD Office shall be responsible for assisting the distribution of the cash incentives, cash prizes, provisions of in-kind items/food packs, ensuring transparency and fairness. The giving of cash incentives,

cash prizes, provisions of in-kind items/food packs shall be distributed based on the established criteria and following the proper documentation and approval processes.

SECTION 4. FUNDING. The amount necessary to fund the cash incentives, cash prizes, provisions of in-kind items/food packs shall be sourced from the Persons with Disability (PWD) Fund.

SECTION 5. EFFECTIVITY. This ordinance shall take effect its approval.
