**MUNICIPAL ORDINANCE NO. 11<sup>th</sup>-150-2025**

**AN ORDINANCE TRANSFERRING THE SEAT OF THE LEGISLATIVE OFFICES FROM THE THIRD FLOOR OF THE MUNICIPAL HALL TO THE NEW LEGISLATIVE BUILDING LOCATED AT CAPISTRANO ST., BARANGAY MADASIGON, MOLAVE, ZAMBOANGA DEL SUR.**

**BE IT ORDAINED** by the Sangguniang Bayan of Molave, Zamboanga del Sur, that:

**SECTION 1. PURPOSE.** The construction of the three (3) storey legislative building of this municipality is still on going, however, the first and second floor of the said building is almost to be completed. As such, there is a necessity that the said building be occupied to serve its purpose.

**SECTION 2. TRANSFER OF THE LEGISLATIVE OFFICES TO THE NEW CONSTRUCTED LEGISLATIVE BUILDING.** The legislative offices composed of the Vice Mayor's Office, SB Office and SB Secretariat Office shall be transferred to the new legislative building located Capistrano Street, Barangay Madasigon, Molave, Zamboanga del Sur.

**SECTION 3. EFFECTIVITY.** This ordinance shall take effect on the fourth quarter of 2025.
