

MUNICIPAL ORDINANCE NO. 11th-151-2025

AN ORDINANCE TEMPORARILY CLOSING THE PORTION OF RAMOS ST. (AT THE BACK OF THE MOLAVE GYM) AS THE DISPLAY AREA OF UKAY-UKAY VENDORS FOR THE MAXIMUM PERIOD OF FORTY FIVE (45) DAYS STARTING FROM MARCH 28, 2025 TO MAY 2025.

BE IT ORDAINED by the Sangguniang Bayan of Molave, Zamboanga del Sur, in session assembled, that:

SECTION 1. PURPOSE. This ordinance was enacted to temporarily closed the portion of Ramos St. for the maximum period of 45 days, starting March 28, 2025 to May 2025, in order to allow the ukay-ukay vendors to occupy the portion of Ramos St. (back of the Municipal Gymnasium) as their display area for their ukay-ulay products in consideration to the Annual Patronal Town Fiesta this coming April 26-27, 2025. Furthermore, aside from giving our vendors an area to sell therein, the income that will be collected for such period can add to the coffer of this municipality.

SECTION 2. REGULATED ACTS. To ensure safety to both the would-be buyers and residents that will visit the subject area, all types of vehicles are prohibited to pass through the above-stated portion of road during the said period. Provided, that upon the effectivity of this ordinance, the LCE through the Municipal Engineer's Office shall post traffic signages "NO ENTRY" for public awareness.

SECTION 3. EFFECTIVITY. This ordinance shall take effect immediately.
