MUNICIPAL ORDINANCE NO. 12th-42-2026

AN ORDINANCE APPROVING THE GRANT OF CASH INCENTIVES, CASH PRIZES, AND PROVISION OF IN-KIND ITEMS/FOOD PACKS FOR PROGRAMS, PROJECTS, AND ACTIVITIES (PPAs) OF THE PERSONS WITH DISABILITY AFFAIRS OFFICE (PDAO), TO BE FUNDED UNDER THE PDAO FUND AND MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN (MCPC) FUND FOR CALENDAR YEAR 2026.

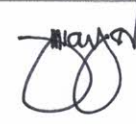
BE IT ORDAINED by the Sangguniang Bayan of Molave, Zamboanga del Sur, in session duly assembled:

SECTION 1. PURPOSE. This Ordinance is enacted to:

- Institutionalize the provision of cash incentives, cash prizes, and in-kind support, including food packs, for programs, projects, and activities (PPAs) of the Persons with Disability Affairs Office (PDAO) for Calendar Year 2026;
- Provide financial and logistical support to activities that promote the welfare, participation, and empowerment of persons with disabilities, including children with disabilities, in the Municipality of Molave;
- Ensure the proper allocation and utilization of funds from the PDAO Fund and the Municipal Council for the Protection of Children (MCPC) Fund in accordance with existing government budgeting, accounting, and auditing laws, rules, and regulations;
- Strengthen the implementation of programs that recognize the rights, capabilities, and contributions of persons with disabilities consistent with the Local Government Code of 1991 and other applicable laws; and
- Promote transparency, accountability, and efficiency in the delivery of services and benefits to the intended beneficiaries.

SECTION 2. APPROVAL OF PROGRAMS, PROJECTS, AND ACTIVITIES (PPAs). The following Programs, Projects, and Activities (PPAs) of the Persons with Disability Affairs Office (PDAO) for Calendar Year 2026 are hereby approved:

- Cash Prizes for Parlor Games during National Disability Rights Week (July 2026)	₱10,000.00
- Cash Prizes for Parlor Games during Year-End PWD Assembly (December 2026)	₱10,000.00



- Cash Incentives for PWD Presidents of twenty-five (25) barangays at ₱500.00 per month	₱150,000.00
- Provision of in-kind items/food packs during National Disability Rights Week (July 2026)	₱75,000.00
- Provision of in-kind items/food packs during Year-End General Assembly (December 2026)	₱75,000.00
MCPC FUND FOR CY 2026	
- Purchase of food packs for children with disabilities in celebration of Children's Month (November 2026)	₱80,000.00

SECTION 3. SOURCE OF FUNDS. The amount necessary for the implementation of the above-mentioned PPAs shall be charged against the PDAO Fund and the Municipal Council for the Protection of Children (MCPC) Fund for Calendar Year 2026, subject to existing budgeting, accounting, and auditing rules and regulations.

SECTION 4. IMPLEMENTATION. The Persons with Disability Affairs Office (PDAO), in coordination with the Municipal Social Welfare and Development Office (MSWDO) and other concerned offices, shall be responsible for the proper implementation and execution of the above-stated programs and activities.

SECTION 5. COMPLIANCE WITH EXISTING LAWS. All disbursements and implementation of activities authorized herein shall be in accordance with applicable laws, rules, and regulations, including auditing and procurement requirements.

SECTION 6. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.
