MUNICIPAL ORDINANCE NO. 12th-44-2026

AN ORDINANCE PROVIDING FOR A TEMPORARY ADJUSTMENT OF MOTORIZED TRICYCLE FARE RATES IN THE MUNICIPALITY OF MOLAVE, ZAMBOANGA DEL SUR DUE TO INCREASE IN FUEL PRICES, AMENDING THE APPROVED MUNICIPAL TARIPA, AND FOR OTHER PURPOSES.

BE IT ORDAINED by the Sangguniang Bayan of Molave, Zamboanga del Sur, in session duly assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as the "Temporary Tricycle Fare Adjustment Ordinance of the Municipality of Molave."

SECTION 2. DECLARATION OF POLICY. It is hereby declared the policy of the Municipality of Molave to ensure a fair, reasonable, and responsive fare system for motorized tricycles for hire, balancing the welfare of commuters and the economic viability of transport operators and drivers. Pursuant to the authority granted under Republic Act No. 7160, the Municipality may regulate tricycle operations and fix rates within its territorial jurisdiction.

SECTION 3. EXISTING MUNICIPAL TARIPA. The approved fare rates for motorized tricycles for hire within the Municipality of Molave, including special rates for students, senior citizens, persons with disabilities, and cargoes, as well as route-based fares outside the Poblacion, shall remain valid and in force, except as modified by this Ordinance.

SECTION 4. TEMPORARY ADJUSTMENT OF MINIMUM FARE (POBLACION AREA). Due to recent increases in oil prices, the minimum fare within the Poblacion Area is hereby temporarily increased as follows:

- From: ₱12.00
- To: ₱20.00 per passenger

This adjusted rate shall apply to all motorized tricycles for hire operating within the Poblacion Area.

SECTION 5. ADDITIONAL FARE FOR ROUTES OUTSIDE THE POBLACION. For routes outside the Poblacion Area, an additional Five Pesos (₱5.00) shall be charged on top of the existing approved fares under the Municipal Taripa.

SECTION 6. CONTINUING APPLICATION OF DISCOUNTS AND SPECIAL RATES. All existing discounts and special fare privileges shall continue to apply, including but not limited to:

- Students
- Senior Citizens
- Persons with Disabilities (PWDs)

- Pregnant Women
- Children

Provided, that:

- a. Students, Senior Citizens, Persons with Disabilities (PWDs), and Pregnant Women shall be granted a discount of Two Pesos (₱2.00) from the applicable full fare;
- b. The discount shall be computed based on the adjusted base fare under this Ordinance and in accordance with existing laws and regulations;
- c. Children above six (6) years old shall be charged the full fare during non-school days; however, in the event that the temporary fare adjustment remains in effect during the school period, such children may avail of the applicable student discount upon proper identification or proof of school attendance;
- d. Children below six (6) years old occupying a seat shall be charged the applicable reduced fare as provided under the existing Municipal Taripa.

SECTION 7. COVERAGE. This Ordinance shall apply to all qualified franchisee/MTOP holders, duly registered and operating within the Municipality of Molave.

SECTION 8. ENFORCEMENT. The Municipal Mayor in coordination with the Traffic Ordinance Enforcers, and Molave Philippine National Police, shall enforce the provisions of this Ordinance.

SECTION 9. PENALTIES. Any driver, operator, or franchise holder who violates the provisions of this Ordinance shall, after due process, be subject to the following penalties:

- 1st Offense: Php200.00
- 2nd Offense: Php500.00
- 3rd Offense: Cancellation of MTOP

SECTION 10. TEMPORARY NATURE OF ADJUSTMENT. The fare adjustment provided under this Ordinance shall remain in full force and effect:

- Until amended, revoked, or superseded by subsequent ordinance; or
- Until such time that fuel prices stabilize, as may be determined by the Sangguniang Bayan.

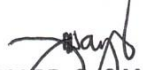
SECTION 11. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions shall remain in full force and effect.

SECTION 12. REPEALING CLAUSE. All ordinances, rules, and regulations inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 13. EFFECTIVITY. This Ordinance shall take effect after compliance with the posting and publication requirements under Republic Act No. 7160.
