MUNICIPAL ORDINANCE NO. 12th-46-2026

AN ORDINANCE APPROVING THE ALLOCATED BUDGET AND OBJECT OF EXPENDITURES FOR THE PROPOSED ACTIVITIES IN LINE WITH THE 78TH ARAW NG MOLAVE CELEBRATION IN THE TOTAL AMOUNT OF THREE MILLION TWO HUNDRED SEVENTY-NINE THOUSAND AND FOUR HUNDRED PESOS (₱3,279,400.00) TO BE SOURCED FROM VARIOUS FUNDS OF THE LOCAL GOVERNMENT UNIT OF MOLAVE.

BE IT ORDAINED by the Sangguniang Bayan of Molave, Zamboanga del Sur, that:

SECTION 1. PURPOSE. This Ordinance is enacted to authorize and approve the allocated budget and objects of expenditures for the various proposed activities in line with the celebration of the 78th Araw ng Molave, aimed at commemorating the founding anniversary of the Municipality of Molave and promoting civic pride, cultural heritage, tourism development, sportsmanship, youth participation, economic promotion, and community involvement among residents and stakeholders of the municipality.

SECTION 2. BUDGET ALLOCATION. The total budget allocated for the celebration of the 78th Araw ng Molave amounted to ₱3,279,400.00, which shall be taken from the following appropriations of the Local Government Unit of Molave for Fiscal Year 2026, to wit:

SECTION 4. AWARDS AND PRIZES. All awards and prizes granted under this Ordinance to the barangays shall be treated and recorded as subsidies to the recipient barangays; hence, the same shall not be subject to liquidation to the LGU, without prejudice to compliance with applicable accounting and auditing rules and regulations.

SECTION 5. DISBURSEMENT AND UTILIZATION OF FUNDS. All disbursements authorized under this Ordinance shall be made in accordance with the provisions of the Local Government Code of 1991 and other applicable budgeting, accounting, auditing, and procurement laws, rules, and regulations issued by the Department of Budget and Management (DBM) and the Commission on Audit (COA).

All claims shall be supported by complete documentation, including disbursement vouchers, payrolls, official receipts, contracts, and other relevant supporting papers, and shall be subject to applicable auditing rules and procedures.

SECTION 6. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.
