UNANIMOUSLY APPROVED, this 7th day of July, 2026 at Molave, Zamboanga del Sur.

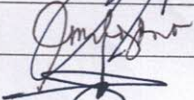
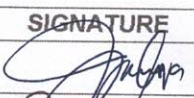
