RESOLUTION NO. 12th-419-2026

A RESOLUTION EARNESTLY REQUESTING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., THROUGH THE MUNICIPAL ECONOMIC ENTERPRISE DEVELOPMENT OFFICE (MEEDO) HEADED BY MRS. SARINA TANTAN, TO ALLOCATE FUNDS FOR THE PROCUREMENT OF A NEW SET OF DTI-COMPLIANT WEIGHING SCALES FOR THE RE-ESTABLISHMENT AND OPERATION OF THE "TIMBANGAN NG BAYAN" PROGRAM AT THE MOLAVE PUBLIC MARKET, IN ACCORDANCE WITH EXISTING LAWS, RULES, AND REGULATIONS.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates local government units to promote the general welfare of their constituents, including the protection of consumers and the regulation of business activities within their jurisdiction;

WHEREAS, Republic Act No. 7394, otherwise known as the Consumer Act of the Philippines, and the rules and regulations issued by the Department of Trade and Industry (DTI), emphasize the importance of ensuring accurate weights and measures in all commercial transactions to protect consumers from unfair trade practices;

WHEREAS, the "Timbangan ng Bayan" program serves as a vital consumer protection mechanism by providing a free and accessible weighing facility in public markets, thereby promoting transparency, fairness in trade, and protection against underweight or inaccurate commercial transactions;

WHEREAS, the Municipality of Molave previously established a "Timbangan ng Bayan" facility at the Molave Public Market; however, the equipment was no longer serviceable, or otherwise rendered unavailable for operational use, thereby necessitating its replacement to restore this important public service;

WHEREAS, during coordination with the Department of Trade and Industry (DTI), it was conveyed that the implementation and maintenance of the "Timbangan ng Bayan" program, including the procurement of the necessary weighing scales, shall now be undertaken by the Local Government Unit, subject to applicable procurement laws and regulations;

WHEREAS, there is a continuing need to re-establish the "Timbangan ng Bayan" facility at the Molave Public Market to ensure that consumers, vendors, and traders are provided with a reliable and impartial reference for weights and measures, thereby promoting fair trade practices and strengthening public trust in market transactions;
