A RESOLUTION DECLARING VALID AND OPERATIVE BARANGAY APPROPRIATION ORDINANCE NO. 01 CY 2026 – AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE HUNDRED ONE THOUSAND SIX HUNDRED EIGHTY-FIVE PESOS AND 11.100 (PHP301,685.11) FOR THE VARIOUS EXPENDITURES OF THE GENERAL FUND OF BARANGAY ALICIA, MOLAVE, ZAMBOANGA DEL SUR AS PER SUPPLEMENTAL BUDGET NO. 01 CY 2026.

WHEREAS, Section 57 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that barangay ordinances enacted by the Sangguniang Barangay shall be submitted to the Sangguniang Bayan for review as to whether the same are consistent with law and municipal ordinances;

WHEREAS, the Sangguniang Barangay of Barangay Alicia submitted for review APPROPRIATION ORDINANCE NO. 01 CY 2026 – AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE HUNDRED ONE THOUSAND SIX HUNDRED EIGHTY-FIVE PESOS AND 11.100 (PHP301,685.11) FOR THE VARIOUS EXPENDITURES OF THE GENERAL FUND OF BARANGAY ALICIA, MOLAVE, ZAMBOANGA DEL SUR AS PER SUPPLEMENTAL BUDGET NO. 01 CY 2026;

WHEREAS, the Supplemental Budget No. 1, CY 2026 of Barangay Alicia is supported with the following requirements:

- BDC Resolution No. 1, S. 2026 –A resolution recommending the approval of Supplemental Annual Investment Plan No. 1, S. 2026 of Barangay Alicia, Molave, Zamboanga del Sur CY 2026".
- Resolution No. 003, S. 2026 – A resolution approving BDC Resolution No. 1, Series of 2026.
- Appropriation Ordinance No. 1, S. 2026 – AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE HUNDRED ONE THOUSAND SIX HUNDRED EIGHTY-FIVE PESOS AND 11.100 (PHP301,685.11) FOR THE VARIOUS EXPENDITURES OF THE GENERAL FUND OF BARANGAY ALICIA, MOLAVE, ZAMBOANGA DEL SUR AS PER SUPPLEMENTAL BUDGET NO. 01 CY 2026.

WHEREAS, the Supplemental Budget No. 1 CY- 2026 of Barangay Maloloy-on is sourced from the following:

- Surplus for Calendar Year 2025 amounting to Php236,685.11;
- Cash Award of Kalinisan Program 2026 amounting to Php50,000.00;
- SGLGB Cash Award amounting to Php15,000.00;

WHEREAS, the appropriated amount of Php301,685.11 is allocated for various barangay expenditures, including the following:

- Purchase of Rice for the Household participated in the Kalinisan Program of Barangay Alicia amounting to Php166,603.11;
- Cash Incentive Award for Household participated the Kalinisan Program of Barangay Alicia amounting to Php72,082.00; and
- Travelling Expenses amounting to Php63,000.00.

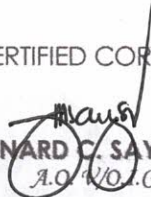
WHEREAS, after review and evaluation, the Sangguniang Bayan finds no provision in Barangay Appropriation Ordinance No. 1, Series of 2026 that is inconsistent with law, municipal ordinances, or applicable rules and regulations;

NOW, THEREFORE, on motion of Honorable Salinas and duly seconded by Honorable Orbita, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

UNANIMOUSLY APPROVED, this 24th day of June, 2026 at Barangay Alicia, Molave, Zamboanga del Sur.

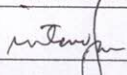
