RESOLUTION NO. 12th-423-2026

A RESOLUTION DECLARING VALID AND OPERATIVE BARANGAY APPROPRIATION ORDINANCE NO. 1 S. OF 2026 OF BARANGAY CULO, ENTITLED: AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION TWO HUNDRED SIXTY-NINE THOUSAND THREE HUNDRED FIVE PESOS AND 41/100 (PHP1,269,305.41) FOR THE VARIOUS EXPENDITURES OF THE GENERAL FUND OF BARANGAY CULO, MOLAVE, ZAMBOANGA DEL SUR, AS PER SUPPLEMENTAL BUDGET NO. 1, S. 2026.

WHEREAS, Section 57 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that barangay ordinances enacted by the Sangguniang Barangay shall be submitted to the Sangguniang Bayan for review as to whether the same are consistent with law and municipal ordinances;

WHEREAS, the Sangguniang Barangay of Barangay Culo submitted for review APPROPRIATION ORDINANCE NO. 1 S. OF 2026 OF BARANGAY CULO, TITLED: AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION TWO HUNDRED SIXTY-NINE THOUSAND THREE HUNDRED FIVE PESOS AND 41/100 (PHP1,269,305.41) FOR THE VARIOUS EXPENDITURES OF THE GENERAL FUND OF BARANGAY CULO, MOLAVE, ZAMBOANGA DEL SUR, AS PER SUPPLEMENTAL BUDGET NO. 1, S. 2026;

WHEREAS, the Supplemental Budget No. 1, CY 2026 of Barangay Culo is supported with the following requirements:

- BDC Resolution No. 1, S. 2026 – A resolution recommending to the Sangguniang Barangay the approval and adoption of Supplemental Annual Investment Program (AIP) No. 01 S. 2026 of Barangay Culo, Molave, Zamboanga del Sur;
- Resolution No. 42 S. 2026 – A resolution approving BDC Resolution No. 1, S. of 2026;
- Appropriation Ordinance No. 01 Series of 2026 – AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION TWO HUNDRED SIXTY-NINE THOUSAND THREE HUNDRED FIVE PESOS AND 41/100 (PHP1,269,305.41) FOR THE VARIOUS EXPENDITURES OF THE GENERAL FUND OF BARANGAY CULO, MOLAVE, ZAMBOANGA DEL SUR, AS PER SUPPLEMENTAL BUDGET NO. 1, S. 2026.

WHEREAS, the Supplemental Budget No. 1 CY- 2026 of Barangay Culo is sourced from the following:

WHEREAS, the appropriated amount of One Million Two Hundred Sixty-Nine Thousand Three Hundred Five pesos and 41/100 is allocated for various barangay expenditures, to wit:

WHEREAS, under Supplemental Budget No. 1, S. 2026, the amount of Nine Hundred Fifty Thousand Pesos (₱950,000.00) is appropriated for the acquisition of a Rescue and Transportation Vehicle.

WHEREAS, the Committee recognizes the necessity and public purpose of acquiring a Rescue and Transportation Vehicle to strengthen the barangay's emergency response capability and support the efficient delivery of official services. The committee further emphasizes that the vehicle to be procured under Supplemental Budget No. 1, S. 2026 shall be brand new to ensure safety, reliability, efficiency, and long-term serviceability for the benefit of the barangay and its constituents, and that its acquisition shall strictly comply with all applicable government procurement laws, rules, regulations, and guidelines.

WHEREAS, after review and evaluation, the Sangguniang Bayan finds no provision in Barangay Appropriation Ordinance No. 1, Series of 2026 that is inconsistent with law, municipal ordinances, or applicable rules and regulations;

NOW, THEREFORE, on motion of Honorable Salinas and duly seconded by Honorable Orbita, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

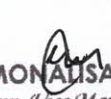
