RESOLUTION NO. 12th-424-2026

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO ENTER INTO AND SIGN, ON BEHALF OF THE MUNICIPALITY OF MOLAVE, THE MEMORANDUM OF AGREEMENT WITH THE ZAMBOANGA CITY MEDICAL CENTER, THE INTEGRATED PROVINCIAL HEALTH OFFICE (IPHO) UNDER THE PROVINCE-WIDE HEALTH SYSTEM (PWHS), THE CITY GOVERNMENT OF PAGADIAN, AND THE MUNICIPAL GOVERNMENTS OF ZAMBOANGA DEL SUR FOR THE IMPLEMENTATION OF TELEMEDICINE SERVICES.

WHEREAS, the Municipality of Molave recognizes that access to quality, timely, and responsive health care services is a fundamental concern of local governance and is committed to supporting programs that promote the health and well-being of its constituents;

WHEREAS, the Zamboanga City Medical Center, represented by Afdal B. Kunting, MD, MPH, FPCP, the City and Municipal Governments of Zamboanga del Sur, and the Integrated Provincial Health Office (IPHO) under the Province-Wide Health System (PWHS), represented by Hon. Divina Grace C. Yu, have proposed the execution of a Memorandum of Agreement for the implementation of telemedicine services throughout the Province of Zamboanga del Sur;

WHEREAS, the proposed Memorandum of Agreement seeks to establish a collaborative framework among the parties to strengthen the delivery of health care services through telemedicine by utilizing information and communication technologies to provide remote medical consultations, referrals, diagnosis, treatment, monitoring, and other health services, particularly for patients in geographically isolated and disadvantaged areas;

WHEREAS, the implementation of telemedicine services will improve the accessibility, efficiency, and quality of public health services by facilitating prompt consultation with medical specialists, reducing unnecessary patient travel and related expenses, improving referral systems, and enhancing the overall delivery of health care within the Municipality of Molave;

WHEREAS, the proposed undertaking supports the implementation of Republic Act No. 11223, otherwise known as the "Universal Health Care Act," which institutionalizes an integrated and comprehensive health care system through Province-Wide and City-Wide Health Systems to ensure equitable access to quality and affordable health care services for all Filipinos;

WHEREAS, the adoption of telemedicine likewise advances the policy of the State under Republic Act No. 11032, otherwise known as the "Ease of Doing Business and

Efficient Government Service Delivery Act of 2018," which encourages government agencies and local government units to adopt digital innovations and technology-driven systems to improve efficiency, accessibility, and responsiveness in the delivery of public services;

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that unless otherwise specifically provided in the Code, no contract may be entered into by the Local Chief Executive on behalf of the local government unit without prior authorization by the Sanggunian concerned;

WHEREAS, after careful review, the Sangguniang Bayan finds that the provisions of the proposed Memorandum of Agreement are consistent with existing laws and policies and that its implementation will significantly benefit the Municipality of Molave and its constituents.

NOW, THEREFORE, on motion of Honorable Orbita and duly seconded by Honorable Uy, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to authorize the Municipal Mayor, Hon. Cyril Reo A. Glepa, M.D., to enter into and sign, on behalf of the Municipality of Molave, the Memorandum of Agreement with the Zamboanga City Medical Center, the Integrated Provincial Health Office (IPHO) under the Province-Wide Health System (PWHS), the City Government of Pagadian, and the Municipal Governments of Zamboanga del Sur for the implementation of Telemedicine Services.

UNANIMOUSLY APPROVED, this 30th day of June, 2026 at Molave, Zamboanga del Sur.
