**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO ENTER INTO AND SIGN A CONTRACT OF SERVICE WITH MR. VICTORIANO A. BORLING AS ASSISTANT MECHANIC OF THE LOCAL GOVERNMENT UNIT OF MOLAVE, ZAMBOANGA DEL SUR.**

WHEREAS, the Municipal Mayor requested authority from the Sangguniang Bayan to enter into and sign a Contract of Service with Mr. Victoriano A. Borling as Assistant Mechanic of the Local Government Unit of Molave, Zamboanga del Sur;

WHEREAS, Mr. Victoriano A. Borling, a resident of Purok Bandera, Barangay Dalaon, Molave, Zamboanga del Sur, has signified his willingness to render services as Assistant Mechanic to augment the manpower requirements of the Local Government Unit;

WHEREAS, his primary duties and responsibilities include conducting preventive maintenance and repair of municipal vehicles and heavy equipment, providing mechanical and electrical support, maintaining the motor pool and related records, responding to emergency repair needs, and performing such other functions as may be assigned by the Municipal Government;

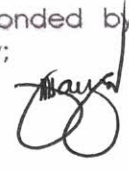
WHEREAS, under the proposed Contract of Service, Mr. Borling shall receive a monthly compensation of Fifteen Thousand Pesos (₱15,000.00), subject to compliance with existing accounting, auditing, budgeting, and other applicable government rules and regulations;

WHEREAS, the Contract of Service shall take effect from July 1, 2026, until December 29, 2026, unless sooner terminated in accordance with the terms and conditions stipulated therein;

WHEREAS, the engagement of Mr. Borling is necessary to ensure the efficient maintenance and operation of the municipality's vehicles and equipment, thereby supporting the continuous delivery of public services;

WHEREAS, the august body adopted the committee's recommendation for the approval of the requested authority,

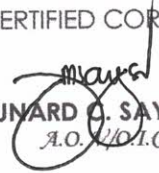
