RESOLUTION NO. 12th-426-2026

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO ENTER INTO AND SIGN A CONTRACT OF SERVICE WITH MR. FELBERN E. LUMAPAS TO SERVE AS OFFICE AIDE UNDER THE MOLAVE WATER SYSTEM OFFICE OF THE LOCAL GOVERNMENT UNIT OF MOLAVE, ZAMBOANGA DEL SUR.

WHEREAS, the Municipal Mayor requested authority from the Sangguniang Bayan to enter into and sign a Contract of Service with Mr. Felbern E. Lumapas as Office Aide under the Molave Water System Office of the Local Government Unit of Molave, Zamboanga del Sur;

WHEREAS, Mr. Felbern E. Lumapas, a resident of Purok Rizal Avenue, Barangay Maloloy-on, Molave, Zamboanga del Sur, has signified his willingness to render services as Office Aide to support the operational requirements of the Local Government Unit;

WHEREAS, his duties and responsibilities include preparing and updating water consumption and billing records, maintaining customer accounts and service connection records, preparing service orders, addressing consumer concerns, managing office files and databases, and performing such other functions as may be assigned by the Municipal Government;

WHEREAS, under the proposed Contract of Service, Mr. Lumapas shall receive a monthly compensation of Twelve Thousand Pesos (P12,000.00), subject to compliance with existing accounting, auditing, budgeting, and other applicable government rules and regulations;

WHEREAS, the Contract of Service shall take effect from July 1, 2026, until December 29, 2026, unless sooner terminated in accordance with the terms and conditions stipulated therein;

WHEREAS, the engagement of Mr. Lumapas is necessary to support the efficient administration and delivery of water service operations and other related functions of the Local Government Unit;

WHEREAS, the august body adopted the committee's recommendation for the approval of the requested authority,

NOW, THEREFORE, on motion of Honorable Orbita and duly seconded by Honorable Uy, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;



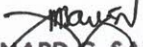
