A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO ENTER INTO AND SIGN AN AGREEMENT BETWEEN THE LOCAL GOVERNMENT UNIT OF MOLAVE AND THE AGRICULTURAL TRAINING INSTITUTE – REGIONAL TRAINING CENTER IX (ATI-RTC IX), REPRESENTED BY ITS OIC-CENTER DIRECTOR, GERRY R. PAGARIGAN, DVM, FOR THE PROVISION OF ACCOMMODATION AND TRAINING HALL FACILITIES FOR THE TRAINING ON CACAO-BASED FARMING SYSTEM (REFRESHER), BATCH 1.

WHEREAS, the Agricultural Training Institute – Regional Training Center IX (ATI-RTC IX), represented by its OIC-Center Director, Gerry R. Pagarigan, DVM, has expressed its intention to engage the services of the Local Government Unit of Molave for the provision of accommodation and training hall facilities for the conduct of the Training on Cacao-Based Farming System (Refresher), Batch 1, scheduled on July 22–24, 2026, in Molave, Zamboanga del Sur;

WHEREAS, the training aims to enhance the knowledge, skills, and competencies of cacao farmers and other stakeholders by providing updated technologies and best practices in cacao production, thereby contributing to the sustainable development of the local agriculture sector;

WHEREAS, the Local Government Unit of Molave has manifested its willingness and capability to serve as the Service Provider by making available its accommodation and training hall facilities for the thirty-five (35) participants of the said training activity;

WHEREAS, under the terms of the Agreement, ATI-RTC IX shall compensate the Local Government Unit of Molave in the total amount of Thirty-One Thousand One Hundred Eighty-Five Pesos (P31,185.00), equivalent to Eight Hundred Ninety-One Pesos (P891.00) per participant, as payment for the accommodation and use of the training hall facilities during the three-day activity;

WHEREAS, the proposed Agreement promotes inter-agency collaboration, maximizes the utilization of existing government facilities, and supports the delivery of quality agricultural extension and capacity-building programs for the benefit of the farming community;

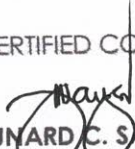
WHEREAS, after review and evaluation, the Sangguniang Bayan finds the proposed Agreement to be in order and in accordance with existing laws, rules, and regulations, and further finds that its execution will serve the best interest of the Municipality of Molave;

NOW, THEREFORE, on motion of Honorable Salinas and duly seconded by Honorable Orbita, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to authorize the Municipal Mayor, Hon. Cyril Reo A. Glepa, M.D., to enter into and sign an Agreement between the Local Government Unit of Molave and the Agricultural Training Institute – Regional Training Center IX (ATI-RTC IX), represented by its OIC-Center Director, Gerry R. Pagarigan, DVM, for the provision of accommodation and training hall facilities for the training on Cacao-Based Farming System (Refresher), Batch 1.
