RESOLUTION NO. 12th-430-2026

A RESOLUTION RESPECTFULLY REQUESTING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO PROVIDE THE NECESSARY APPROPRIATION FOR THE IMPLEMENTATION OF THE ASPHALT OVERLAY PROJECT FOR THE DAMAGED AND DETERIORATED CONCRETE PAVEMENT IN FRONT OF THE MUNICIPAL HALL.

WHEREAS, the Municipality recognizes the importance of maintaining safe, accessible, and functional government facilities to ensure the efficient delivery of public services and protect the welfare of government employees and constituents;

WHEREAS, the Office of the Municipal Engineer assessed the concrete pavement in front of the Municipal Hall and found that it has deteriorated due to prolonged use and exposure to the elements, resulting in surface defects, cracks, and uneven portions requiring immediate intervention;

WHEREAS, the Office of the Municipal Engineer recommended the implementation of an Asphalt Overlay Project and prepared the corresponding Program of Works with an estimated project cost of ₱2,527,741.71, covering an estimated area of 1,326 square meters;

WHEREAS, pursuant to Resolution No. 12th-429-2026, the Sangguniang Bayan approved the Program of Works (POW) for the Asphalt Overlay Project, having found the proposed project necessary to improve public safety, accessibility, and the overall condition of the Municipal Hall premises;

WHEREAS, the successful implementation of the project requires the availability of funds through an appropriate budgetary allocation, consistent with existing laws and regulations governing the use of public funds;

NOW, THEREFORE, on motion of Honorable Geromo and duly seconded by Honorable Cabasag, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to respectfully request the Municipal Mayor, Hon. Cyril Reo A. Glepa, M.D., to provide the necessary appropriation for the implementation of the Asphalt Overlay Project of the damaged and deteriorated concrete pavement in front of the Municipal Hall.
