A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO ENTER INTO AND SIGN, FOR AND ON BEHALF OF THE MUNICIPALITY OF MOLAVE, THE MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF ZAMBOANGA DEL SUR, REPRESENTED BY HON. DIVINA GRACE C. YU, PROVINCIAL GOVERNOR, FOR THE IMPLEMENTATION OF THE PERFORMANCE-BASED GRANT (PBG) UNDER THE HEALTH SYSTEM RESILIENCE PROJECT (HSRP).

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers local government units to promote the general welfare of their inhabitants through measures that enhance health, safety, and the effective delivery of basic services;

WHEREAS, Republic Act No. 11223, otherwise known as the Universal Health Care Act, institutionalizes an integrated and comprehensive health care system that ensures equitable access to quality health services and encourages collaboration among national agencies and local government units in strengthening local health systems;

WHEREAS, the Provincial Government of Zamboanga del Sur and the Municipality of Molave have agreed to collaborate in the implementation of the Performance-Based Grant (PBG) under the Health System Resilience Project (HSRP) through a Memorandum of Agreement, with the objective of improving health system performance, strengthening accountability, and enhancing the delivery of quality health services;

WHEREAS, under the proposed Memorandum of Agreement, the Provincial Government of Zamboanga del Sur shall receive and manage the Performance-Based Grant through the Special Health Fund, facilitate the timely downloading of funds, provide technical assistance, monitoring, validation, and oversight, and ensure compliance with the applicable policies, standards, and guidelines of the Department of Health, Department of Budget and Management, Department of Finance, and the Commission on Audit;

WHEREAS, the Municipality of Molave shall implement the approved health programs and activities funded by the grant and shall ensure the proper utilization, accounting, liquidation, monitoring, reporting, and management of public funds in accordance with existing budgeting, procurement, accounting, auditing, and transparency laws, rules, and regulations;

WHEREAS, the proposed Memorandum of Agreement likewise provides clear provisions on financial management, monitoring and evaluation, reporting requirements,

data privacy protection, and its effectivity until 30 June 2030, thereby establishing an adequate framework for the efficient and accountable implementation of the project;

WHEREAS, the Sangguniang Bayan finds that entering into the Memorandum of Agreement is consistent with existing laws and government policies and will significantly contribute to strengthening the Municipality's health system, improving institutional capacity, and ensuring the continued delivery of accessible, responsive, and quality health services to the people of Molave;

NOW, THEREFORE, on motion of Honorable Orbita and duly seconded by Honorable Salinas, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to authorize the Municipal Mayor, Hon. Cyril Reo A. Glepa, M.D., to enter into and sign, for and on behalf of the Municipality of Molave, the Memorandum of Agreement with the Provincial Government of Zamboanga del Sur, represented by Hon. Divina Grace C. Yu, Provincial Governor, for the implementation of the Performance-Based Grant (PBG) under the Health System Resilience Project (HSRP).

UNANIMOUSLY APPROVED, this 7th day of July, 2026 at Molave, Zamboanga del Sur.

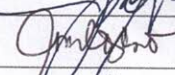
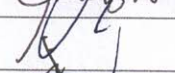
