RESOLUTION NO. 12th-438-2026

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO SIGN AND EXECUTE A DEED OF DONATION AND ACCEPTANCE WITH THE NATIONAL COUNCIL ON DISABILITY AFFAIRS (NCDA), REPRESENTED BY EXECUTIVE DIRECTOR, GLENDA D. RELOVA, AND TO ACCEPT, ON BEHALF OF THE MUNICIPALITY OF MOLAVE, THE DONATION OF ONE (1) DESKTOP COMPUTER AND ONE (1) SIGNATURE PAD INTENDED FOR THE PERSONS WITH DISABILITIES (PWD) ID REGISTRATION AND DATA ENCODING SYSTEM.

WHEREAS, the National Council on Disability Affairs (NCDA), in furtherance of its mandate to promote and protect the rights and welfare of persons with disabilities, has offered to donate one (1) desktop computer and one (1) signature pad to the Municipality of Molave to strengthen the implementation of the Persons with Disability (PWD) Identification Card Registration and Data Encoding System;

WHEREAS, the donated equipment is intended to enhance the Municipality's capability to process PWD Identification Card applications, accurately encode and maintain records, and facilitate the timely uploading of data to the Philippine Registry of Persons with Disabilities (PRPWD) maintained by the Department of Health, thereby improving the delivery of government services to persons with disabilities;

WHEREAS, the acceptance of the donation will significantly contribute to the efficient implementation of Republic Act No. 7277, otherwise known as the Magna Carta for Persons with Disability, as amended by Republic Act No. 9442 and other relevant laws, by strengthening the Local Government Unit's capacity to provide accessible, responsive, and technology-assisted services to qualified beneficiaries;

WHEREAS, the Sangguniang Bayan recognizes that the donated equipment is intended solely for encoding and updating of data of persons with disability and will directly support the Municipality's continuing commitment to uphold the rights, welfare, and inclusion of persons with disabilities through improved public service delivery;

WHEREAS, Sections 22 and 35 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize local government units to receive grants and donations for public purposes, subject to the approval of the Sangguniang Bayan through an appropriate legislative measure;

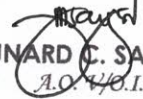
WHEREAS, it is necessary to authorize the Municipal Mayor to formally accept the donation and execute the corresponding Deed of Donation and such other documents as may be necessary to effect its lawful acceptance and implementation;

NOW, THEREFORE, on motion of Honorable Perong and duly seconded by Honorable Orbita, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to authorize the Municipal Mayor, Hon. Cyril Reo A. Glepa, M.D., to sign and execute a Deed of Donation and Acceptance with the National Council on Disability Affairs (NCDA), represented by Executive Director, Glenda D. Relova, and to accept, on behalf of the Municipality of Molave, the donation of One (1) Desktop Computer and One (1) Signature Pad intended for the Persons with Disabilities (PWD) ID registration and data encoding system.

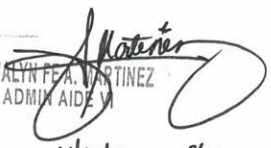
